

## North Carolina Bar Association Positional Membership Application

This application is valid until June 30, 2020. Applicants who join after March 14 have valid membership through the following fiscal year ending June 30.

### What Is A Positional Membership In The North Carolina Bar Association?

A positional membership is a NCBA membership paid for by a State government agency. The membership is assigned by the agency to a designated full-time employee position. The membership is tied to that designated position within the agency, not the individual. An individual receiving a positional membership enjoys all the benefits of a regular NCBA member.

### Who qualifies for a Positional Membership?

You qualify for a positional membership if you are:

- Employed by a State government agency\*
- Employed full time
- Licensed in North Carolina
- In good standing with the North Carolina State Bar

\*A State government agency is defined as an agency, authority, board, commission, council, department, office, institution, constitutional office of the State, the General Assembly, universities, community colleges, the judiciary, and the Administrative Office of the Courts, including district attorneys and public defenders.

**What is the cost of a Positional Membership?** The dues for a positional membership are \$360 per year regardless of the year the attorney receiving the positional membership was licensed to practice.
